4. Economic Development

a. Produced Kalispell's first Growth Summit to convene stakeholders across the valley to discuss development, transportation, housing, and child care. b. Concluded a 4-month child care initiative resulting in an action plan for 2022. c. Began coalition building to advocate for federal infrastructure dollars. d. Launched Discover Kalispell MT as an aspirational community brand at our successful November Annual Reception and Grand Event. Kalispell is the brand. Venture BOLDLY is our tagline. A vibrant mountain town that believes in boundless adventures, loving the earth and venturing boldly. Venture boldly encapsulates the spirit and ethos of Kalispell, where a wild and majestic landscape calls adventurous and spirited travelers and business owners to climb one more peak or embrace their biggest dreams. **e.** In collaboration with partners at FVCC and the Kalispell Job Service launched the first virtual Opportunity Fair, conducted 2 Lemonade Days for our young entrepreneurs.

5. Promoting a Vibrant Downtown Kalispell

- a. Actively participated in the Kalispell Downtown Association and Kalispell Business Improvement District and Developers group. b. Promoted Small Business Season from November 27 through December 24th and served as the Neighborhood Champion for Small Business
- 6. Added 118 new members over the past twelve months to expand our network and strengthen our organization resulting in the largest yearend we have achieved with 708 members.
- 7. With appreciation to our sponsors and members, we had a financially successful 117th annual meeting where we recognized Tom Esch with the Flathead Community Legacy Award (formerly Great Chief), Western Building Center – Large Business of the Year, Waters Edge Winery & Bistro – Small/Medium Business of the Year, Jerry Meerkatz – Business Person of the Year, Lizzy Sheeran - Rising Star of the Year, Noreen Cady -Community Spirit of the Year, Non-profit of the Year - Samaritan House.



- The 59901 zipcode (Kalispell) had the highest number of new business licenses in the state. Over 7,000 new businesses registered.
- Investor group, MT Hotel Dev Partners, successfully entered into a public-private partnership to build on Main Street since 1912 when the Grand was opened. The project includes a 4-5 story parking garage, 83+ rooms, a bar and lounge, retail spaces, meeting space and a rooftop bar.
- Hayden Tanner closed on the former CHS Agronomy Center to complete the four rail park/parkline property parcel sales. They anticipate a mixed-use (residential, commercial), high density project.
- Flathead Warming Center opened its doors on North Meridian Road. The center is a low barrier access shelter that will serve up to 40 residents per night during the winters. More than 100 volunteers keep the doors open.
- Pioneer Baseball's newest team, Glacier Range Riders was announced. The Kelly family broke 6 ground on the state of the art facility in the spring and will host Opening Day June 14, 2022.
- Realtors and mortgage lenders continued to see increases in the number and size of real estate transactions in the Flathead Valley. Our market remains tight with very limited supply, both for sale and rent.
- Glacier Park International Airport experienced a 16% increase in enplanements over 2019 and the highest number ever. Three new carriers were added resulting in four new destinations. The terminal expansion broke ground and is to be completed in 2023.
