Dear Secretary,

The Kalispell Chamber of Commerce is pleased to support the City of Kalispell's RAISE Grant application for the West Reserve Road expansion project from the Hutton Ranch Road intersection to the Whitefish Stage intersection on behalf of our 741 members representing 17,000+ employees in Kalispell and the Flathead Valley.

With the successful completion of the Kalispell Alternate 93 Bypass, this next step is essential to achieve five community transportation goals.

- Improve safety and reduce accidents in support of the Montana Department of Transportation's Zero goal.
- Accommodate existing and future travel demands, therefore reducing travel times and emissions
- Improve intersection operations and levels of service
- Improve non-motorized travel options and safety
- Employ travel demand management strategies

Kalispell is now the fastest growing Micropolitan City in the Nation. Pairing this with the impacts of non-resident tourism growth and the \$100 million expansion to Glacier Park International Airport as well as the expected growth to area businesses, it is clear the current roadway and intersections are insufficiently sized and designed to accommodate the demand now and in the future. We acknowledge that it is imperative we are able to include sidewalks and intersection crossings to be built for ADA compliance to serve all community members and visitors.

As the highest trafficked and greatest bottlenecked portion of this vital east-west connector in our city due to the business & commercial connections it serves as, we respectfully urge you to support the Kalispell RAISE grant to improve and widen West Reserve Road.
